Continuing east on Rt. 100 to, and crossing, Rt 2 to Rt. 177 (Mountain Rd.) then continuing on Rt. 177 (Mountain Rd.) to Gibson Island ending at the Bay.; East: The Bay; South: Rt. 50 from the Prince Georges County/ Anne Arundel County Line to the Bay; West: The Prince Georges County/ Anne Arundel County Line from Rt. 50 north to the railroad line north to Rt. 175 (Jessup Rd.)
